1. Opening of Meeting

1.1 Minutes for the Climate Change Advisory Council Meeting 16.12.2021

The minutes were accepted.

Matters arising from the minutes

The Chair referred to the strategy paper of the International Climate Council Network (ICCN) which was circulated to Council members prior to the meeting, noting that their strategy session was also being held on 19.01.2022. Council also noted that the ICCN have requested that the hosting of the network would rotate amongst members and that Ireland may host in coming years.

It was agreed that expressions of interest will be sought for at least two further Committee members. This will invite expressions of interest from those with suitable qualifications, expertise and experiences in a number of previously identified areas including those listed at Section 9(4)(a)(i)-(x) of the Climate Act and within sectors with sectoral adaptation plans.

The terms of reference of the Committee will be updated in due course. This will reflect that ex officio Council members of the Committee can nominate substitutes to attend the Committee on their behalf if required or appropriate. They will formalise how Council members may attend Committee meetings. Also it was agreed that external Committee members should be limited to two consecutive terms.

The next meeting of the Committee will be held on 24th February 2022.

The Council noted the Secretariat proposal to respond to DECC's early stakeholder consultation on the NAF with a signpost document highlighting previous Council advice and recommendations. Council approved the draft letter and signpost document to DECC.

Council Research 2021 – Presentations
(a) Hydrogen - Small Scale Study

Dr. Niall Farrell presented the draft report from the Hydrogen small scale study which was was previously circulated to Council (in meeting papers 16.12.2021).

(b) Forest Management Small Scale Study

Dr. Ken Byrne presented the small-scale study on Forest Management 'Review of the impact of management practices on stand level carbon balance in Irish Forests'.

4. Council Research 2022

a) Topic Priorities 2022

The Secretariat presented a revised document outlining proposed research for 2022. Council accepted the recommendation to approve the progression of this research.

Council also noted the CRCG Annual Report of Activities.
